Dr. Nesbitt is an associate professor of Atmospheric Sciences in the School of Earth Society, and Environment, with affiliate appointments in the Computational Science and Engineering program and the Center for Latin American Studies. He has served and chaired on numerous department committees including the department executive committee, curriculum committee, and faculty searches. He served on the LAS Policy and Development Committee, Honors Council, Dean's Faculty Information Team, and two terms on the General Education Council. He has served the American Meteorological Society as Editor of the *Journal of Applied Meteorology and Climatology*, chaired the national conference on Radar Meteorology, and chaired the Radar Meteorology Committee, for the last he was given an *AMS Distinguished Service Award*.
